

NOW THIS DEED OF TRUST WITNESSETH AS FOLLOWS:

1. The Author of the Trust do hereby declare a sum of Rs.10,001/- (Rupees Ten Thousand and One Only) contributed by him as Trust Property and transfers, assigns, conveys and delivers unto the Trustees the said sum in cash, the receipt of which the Trustees hold and possessed of the same in Trust as Trust Fund (which term shall mean and include not only the said sum of Rs.10,001/- declared as Trust Property under these presents but also the additions and accretions etc., and all the investments for the time being representing the same for certain specified charitable objects) and accordingly, the trustees hereby declare that they shall continue to hold the trust funds in trust for these objects and purposes in accordance with the terms and conditions contained in these presents.
2. The name of the Trust shall be "CHAITANYA EDUCATIONAL TRUST" and its administrative office shall be situated at No.85, 1<sup>st</sup> Main, Okalipuram, Bangalore-560 021.
3. In the interpretation of this Deed unless the context otherwise so requires, the following words and expressions shall have the following meanings respectively attached thereto;

"THE YEAR" means the period beginning with the first day of April in any year and ending with 31<sup>st</sup> day of March following.

"THE TRUST PROPERTY" means the said sum of Rs.10,001/- (Rupees Ten Thousand and One Only) constituting of the said fund and all donations whether in money or in property movable and/or immovable of any kind and/or all additional moneys which may from time to time be collected by the Trustees to be held upon the Trust of this Deed and all money and/or properties of every kind given, donated or bequeathed for the purposes of the Trust of this Deed and all other additions thereto and the investments and property for the time being representing the same and all moneys, shares, stocks, funds and securities and other properties movable or immovable which may under the Trust and provisions of these presents be substituted or added thereto and for the time being subject to the Trust of this Deed.

Words denoting the singular number shall include the plural and vice-versa and words denoting the masculine gender shall include the feminine and vice-versa.

- ii) Smt.Pooja P.Kamat,
- iii) Sri. Amit P. Kamat,

The aforesaid Trustees shall hold office for the life and Sri.Pramod R. Kamat shall be the Chairman and Managing Trustee of the Trust.

5. The Trustees shall stand possessed of the Trust Fund and all income arising therefrom UPON TRUST from time to time to pay or apply such income of the Trust Fund in paying or discharging all costs, charges and expenses of the Trustees of or incidental to the administration or execution of the trust or powers thereof, or the management of the charity hereby constituted and the properties movable or immovable thereof AND SUBJECT THERETO shall pay or apply the net income or if and whenever such income shall in the view of the Trustees be insufficient therefor then out of capital of the Trust Fund in perpetuity for one or more of the following objects and purposes in accordance with the provisions hereinafter contained that is to say-

- i) To establish and run schools, colleges, vocational training centres, polytechnics and generally provide education and job opportunities to students and youth belonging to the economically weaker sections of the society.
- ii) To establish, maintain and run boarding houses, hostels and residential buildings for the students, teachers and other persons connected with the educational institutions.
- iii) To establish and operate orphanages anywhere in India and to support and aid educational pursuit anywhere in India and also to give scholarship, prizes and other monetary benefits to the poor students and render all services to the orphans and poor students anywhere in India.
- iv) To organize seminar, lectures, symposia, conferences and the like for purposes of promotion of social, environmental, economical and general awareness and diffusion of knowledge on matters of public and national interest or importance.

- v) To publish journals, periodicals, books, pamphlets and or any other literature to propagate knowledge and social awareness.
- vi) To accept donations, grants, presents and other offerings from any person or persons and to utilize the same for the purpose of the Trust and such donations shall be kept as part of the Corpus of the Trust and shall not be treated as income of the Trust.
- vii) To pay out from the income of the Trust, stipends and scholarships to poor and deserving students to pursue higher education
- viii) To donate in cash or kind to any other organization, movement, or such similar organizations which are established for the welfare and benefit of society and which have objectives similar to that of this Trust and to support such society, organization or movement in any way possible and to render all assistance whether monetary or otherwise to such organization, society, or movement which are established with national and social objectives and the alleviation of poverty.
- ix) To contribute donations to any public charitable funds authorized by the Income - Tax Act, 1961 and to carry out any other object declared by law to be charitable and beneficial and not inconsistent with Section 2(15) of the Income Tax Act, 1961.
6. The Trustees shall subject to the provisions of any law for the time being in force relating to charities from time to time, without infringing the provisions of Section 13 of the Income - Tax Act, 1961, invest any part of the capital or income of the Trust Fund in such investment (being the investment authorized by law and in particular the Income - Tax Act, 1961, for the investment of Trust Funds) or in deposits in any Nationalised Bank/s and/or subject to the provisions of any law relating to investment of funds of charities, may sell or realize any such investment made including of any moneys deposited as aforesaid.
